4. Participation

Personnel of Phatthalung Provincial Education Office must promote public participation on Phatthalung Provincial Education Office procedure which indicates the transparent and verifiable administration with the intention as public service provision for national benefit.

5. Accountability

Personnel of Phatthalung Provincial Education Office must intend to be a good citizen. They will respect individual right and duties, take cognizance of the differences by democratic principle, and sacrifice for the public. They shouldn't use the public benefit for their own.

6. Value for money

Personnel of Phatthalung Provincial Education Office must use asset or national budget to be beneficial, worthwhile, truly fulfilling the governmental purpose. They shall constantly concern that the state property and budget derive from people's tax.

7. Responsibility

Personnel of Phatthalung Provincial Education Office in terms of responsibility, show honest intention when administrate and be responsible whenever proved guilty of works.

8. Without corruption

Personnel of Phatthalung Provincial Education Office without corruption in the work environment every staff in the organization has to make the office clean of corruption by work policies and will not use the position in all forms of bribe.

9. Culture in the organization

10. Integrity of work in the office
